- Trial run to be completed 3-4 months prior to the wedding
- Please arrive for your appointments ON TIME
- Bring inspiration pictures with you
- Wear a button down shirt
- Please arrive with clean, dry hair and freshly cleansed skin with no makeup  
(There will be a \$10 additional charge if we need to blow dry prior to styling)
- If you have a preferred lipstick bring it with you.
- 3 person minimum per stylist for receiving services on location in our local area. 5 person minimum per stylist for receiving services on location outside of our local area.

## DEPOSIT

\_\_\_\_\_The deposit is the total of the brides trial run, and if applicable the travel and Sunday/Holiday fee. Your wedding date will be held when we receive the deposit and the completed contract. The deposit is used for the trial run, and any travel/ Sunday/Holiday fees. Deposit can be paid by cash, check, Venmo or credit. If using credit there will be a 10% processing fee added.

## ADDED FEES

\_\_\_\_\_A 20% Gratuity is included with each service total.

\_\_\_\_\_Please advise your wedding party of the pricing and that we accept credit, cash, check, Venmo and that a 20% gratuity is included in their total.

\_\_\_\_\_Sunday/Holiday weddings will have a \$75 per stylist fee added and due at time of deposit.

\_\_\_\_\_On location weddings will have a travel fee added and due at time of deposit.

0-29 miles (local area)	\$75 per stylist
30-49 miles (outside local area)	\$100 per stylist plus \$.67 per mile

## SERVICE/PARTY CHANGES– CANCELLATION POLICY

\_\_\_\_\_Cancellations or changes may be made anytime up to 30 days prior to the wedding without penalty. Any changes or cancellations within 30 days of the wedding will result in 100% of the total service fee being charged to the credit card on file.

## TRIAL RUN

\_\_\_\_\_We do require a trail run for the bride 3-4 months prior to the wedding. The trial run is a 1 hour appt per service. If more than 1 hour per service is needed then it will be charged as a second trial run. The wedding party is not required to have a trail run but if anyone in the party chooses to have a trail run their trial run service total plus gratuity would be due at the time of deposit.
